



## **Mini Morgans Nursery – Parent Privacy Notice**

### **Who we are**

Mini Morgans Nursery is responsible for how we collect, store and use personal information relating to children and their parents/carers. We are committed to handling personal information lawfully, fairly and securely in line with UK data protection legislation.

---

### **What information we collect**

We may collect and store information including:

#### **About children**

- Name, date of birth, address and nationality/ethnicity
- Attendance information
- Medical information, allergies and dietary requirements
- Learning and development records
- Photographs and/or video observations used to support children's learning and development, learning journals and nursery displays
- Accident, incident and safeguarding records
- Emergency contact details

#### **About parents/carers**

- Names, addresses, phone numbers and email contact details
  - National Insurance number, date of birth where required for funding purposes
  - Billing and payment information

### **CCTV and security**

Mini Morgans operate CCTV systems in internal and external areas of the nursery for safety, security, safeguarding and welfare purposes. CCTV footage is securely stored and access is restricted to authorised persons only in line with the nursery's safeguarding and data protection procedures

### **Why we use this information**

We use personal information to:

- Provide childcare and early years education

- Support children’s learning and development
  - Keep children safe and meet safeguarding duties
  - Manage nursery administration, funding and invoicing
  - Communicate with parents/carers
  - Meet legal and regulatory requirements
  - Use anonymised information to help identify trends, monitor progress and support the ongoing improvement of nursery provision and practice

### **Sharing information**

We may share relevant information where necessary and lawful with:

- Local authorities for funding and safeguarding purposes
- Ofsted and other regulatory bodies
- Health professionals and safeguarding agencies where appropriate
- Schools or childcare providers to support transitions and/or children’s learning and development
- Third party agencies and software providers used to support nursery operations, finance and learning journals

We only share information where there is a lawful and legitimate basis to do so and ensure access is restricted to authorised persons only.

---

### **Our lawful basis**

We process personal information under:

- Contract – to provide childcare services
- Legal obligations – including safeguarding requirements
- Legitimate interests – to operate and manage the nursery effectively
- Public interest where required by law

Where consent is required, this will be requested separately.

---

### **Keeping information secure**

We take appropriate steps to protect personal information through secure systems, restricted access and data protection procedures.

---

### **How long we keep information**

We only retain information for as long as necessary in line with legal and regulatory requirements.

---

### **Your rights**

You have the right to request access to your personal information, request corrections, request deletion in certain circumstances and raise concerns with the Information Commissioner's Office (ICO).
